2. Due to present COVID-19 pandemic, the Interview will be conducted online. Therefore, every candidate should have required online facility to attend the interview online. The link (google meet) for the interview will be provided once the application is received and verified by the University. It will be the sole responsibility of candidate to get ready with proper internet connection, speaker, microphone etc. The University will not be responsible for poor internet connectivity or any other problem during online interview at the candidate's end.
3. Any type of corrigendum/addendum/amendments/notice/updation etc. related to this advertisement shall be uploaded on University websites www.cup.edu.in only. Further, the university will not send any further information/call letters by post/newspapers. CUPB will not be responsible for invalid/wrong email ID and Mobile No. mentioned by the candidates. 18.
