## The Statutes of the University

1.	(1) The Chancellor shall be appointed by the Visitor from a panel of not less than three persons recommended by the Executive Council from amongst persons of eminence in the academic or public life of the country:	Chancellor
	Provided that if the Visitor does not approve of any of the persons so recommended, he may call for fresh recommendations from the Executive Council.	
	(2) The Chancellor shall hold office for a term of five years and shall not be eligible for re-appointment:	
	Provided that notwithstanding the expiry of his term of office, the Chancellor shall continue to hold office until his successor enters upon his office.

	(2) The Committee referred to in clause (1) shall consist of five persons, out of whom three shall be nominated by the Executive Council and two by the Visitor, and one of the nominees of the Visitor shall be the convener of the Committee:	
	Provided that none of the members of the Committee shall be an employee of the University or a College or an Institution maintained by the University or a member of any authority of the University.	
	(3) The Vice–Chancellor shall be a whole-time salaried officer of the University.

Provided that if the Vice-Chancellor assumes or	
relinquishes charge of the office of the Vice-Chancellor	
during the currency of a half year, the leave shall be	
credited proportionately at the rate of two and-a-half	
days for each completed month of service.

the rate of twenty days for each completed year of

(7) If the office of the Vice-Chancellor becomes vacant due to	
death, resignation or otherwise, or if he is unable to perform	
his duties due to ill-health or any other cause, the Pro-Vice-	
Chancellor shall perform the duties of the Vice Chancellor.	
Provided that if the Pro-Vice-Chancellor is not available, the	
senior-most Professor shall perform the duties of the Vice-

3.	(1) The Vice-Chancellor shall be ex officio Chairman of the Executive Council, the Academic council and the Finance Committee and shall, in the absence of the Chancellor, preside at the Convocations held for conferring degrees and at meetings of the Court.	Powers and Duties of Vice-Chancellor
	(2) The Vice-Chancellor shall be entitled to be present at, and address, any meeting of any authority or other body of the University, but shall not be entitled to vote thereat unless he is a member of such authority or body.	
	(3) It shall be the duty of the Vice-Chancellor to see that this Act, the Statutes, the Ordinances and the Regulations are duly observed and he shall have all the powers necessary to ensure such observance.	
	(4) The Vice-Chancellor shall have all the powers necessary for the proper maintenance of discipline in the University and he may delegate any such powers to such person or persons as he deems fit.	
	(5) The Vice-Chancellor shall have the power to convene or cause to be convened the meetings of the Executive Council, the Academic Council and the Finance Committee.
