The qualification and experience required for teaching posts will be as per "UGC REGULATIONS ON MINIMUM QUALIFICATIONS FOR APPOINTMENT OF TEACHERS AND OTHER ACADEMIC STAFF IN UNIVERSITIES AND COLLEGES AND MEASURES FOR THE MAINTENANCE OF STANDARDS IN HIGHER EDUCATION, 2018 and its subsequent amendments.
  2. **Ph.D. degree shall be mandatory.**
  3. For faculty positions of Department of Computer Science & Technology, minimum eligibility conditions will be as per AICTE 2019 regulations and its amendments from time to time
  4. For faculty positions of Department of Pharmaceutical Sciences and Natural Products, minimum eligibility conditions will be as per Pharmacy Council of India (PCI) Regulations issued from time to time. Further, the candidate must be a registered Pharmacist.

- 1. Applicants are required to apply online (through recruitment portal: <https://cuprec.samarth.edu.in/>). The application fee of Rs. 100/- (for candidates other than SC/ST/PWD/Women) should be deposited while filling the online application form on/before **30.09.2021 upto 23:59:59 hrs****
2. Due to present COVID-19 pandemic, the Interview will be conducted online. Therefore, every candidate should have required online facility to attend the interview online. The link (google meet) for the interview will be provided once your application is received and verified by the University. It will be the sole responsibility of candidate to get ready with proper internet connection, speaker, microphone etc. The University will not be responsible for poor internet connectivity or any other problem during online interview at the candidate's end.
3. Any type of corrigendum/addendum/amendments/notice/updation etc. related to this advertisement shall be uploaded on University websites [www.cup.edu.in](http://www.cup.edu.in) only. Further, the university will not send any further information/call letters by post/newspapers. CUPB will not be responsible for invalid/wrong email ID and Mobile No. mentioned by the candidates. 12. The right is also reserved with the university either to fill or not to fill the vacancies. The decision of Competent Authority of the university in this regard shall be final.
13. Application fees once paid shall not be refunded under any circumstances. Before applying for the post, candidates are advised to satisfy themselves about their eligibility.
14. Upper age limit, qualification and experience etc. will be counted as on the date of Interview.
15. The candidates having experience of working in Central/State Government universities will be preferred.
16. The candidates will not have any claim on regular position/absorption.
17. Canvassing in any form may lead to cancellation of candidature.
18. Incomplete applications or without relevant supporting enclosures (self-attested copies of degree/certificates /marks sheets/experience certificate, etc.) will be out-rightly rejected.
